SCHOLARSHIP AMOUNT:	\$750.00
ELIGIBILITY:	Applicant must be a high school senior or currently enrolled in a school of advanced education: i.e., junior college, four-year college, university, or business school. Austin LPA members or their children are not eligible for the scholarship according to the latest ruling from NALS.
APPLICATIONS:	Scholarship applications must be completed in accordance with the Austin LPA Standing Rules currently in effect. Scholarship applications must be signed and submitted to the Awards Chairmen by the sponsoring chapter. Applications must be postmarked no later than January 6, 2012 . Any application postmarked after that date will be returned to the sponsoring chapter.
ANNOUNCEMENT OF WINNER:	The winner of the scholarship will be announced at the Recognition Banquet January 24, 2012; however, the winner will be advised no later than January 17, 2012. The chairmen will also notify the Marketing Chairman and <i>The Verdict</i> Editor of the name of the successful candidate(s).
AWARD PRESENTATION:	A scholarship certificate will be presented at the Recognition Banquet to the recipient.
PAYMENT OF AWARD:	(1) The Austin LPA scholarship is payable in one payment of \$750 at the beginning of the fall semester. (2) Payments will be made directly to the recipient or to the school upon receipt of proof of enrollment. The proof of enrollment form will be utilized by the Austin LPA Scholarship Chairmen to process the funds for payment.
